- => Must meet or exceed **ALL** requirements specify in this advertisement. The images are used as an example, your offer must meet the technical description given.
- => Offer must be valid for three (3) months
- => We will only contact you if your offer was chosen

**It is advisable to attach all mandatory documentation requested that supports your offer.**

**U.S. vendors:** you can send a proposal in USD, but all prices must be DDP at our warehouse in Bogota. You will need to have a branch or an authorized importer here in Colombia to meet the Incoterm DDP and the domestic regulations.

The U.S. Embassy will NOT emit a tax exemption certification for Colombian taxes  
 DELIVERY TERMS: DDP DELIVERY AT THE EMBASSY WAREHOUSE IN BOGOTA. "Delivered Duty Paid" the seller delivers the goods when the goods are placed at the disposal of the buyer, cleared for import on the arriving means of transport, and ready for unloading at the named place of delivery. The seller bears all the costs and risks involved in bringing the goods to the place of destination, has an obligation to clear the goods not only for export but also for import, to pay any duty for both export and import, and to carry out all customs formalities.
